A BILL

To amend the Agricultural Act of 2014 to improve the supplemental agricultural disaster assistance programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SUPPLEMENTAL AGRICULTURAL DISASTER AS-**
4 **SISTANCE.**

5 (a) IN GENERAL.—Section 1501 of the Agricultural
6 Act of 2014 (7 U.S.C. 9081) is amended—

7 (1) in subsection (b)(1)—

8 (A) in the matter preceding subparagraph

9 (A), by striking “2012” and inserting “2019”;

1 (B) in subparagraph (A), by striking “or”
2 at the end;

3 (C) in subparagraph (B), by striking the
4 period at the end and inserting “; or”; and

5 (D) by adding at the end the following:

6 “(C) disease in livestock that has been ex-
7 acerbated by adverse weather described in sub-
8 paragraph (B)—

9 “(i) subject to the condition that a li-
10 censed veterinarian shall verify that the
11 adverse weather created conditions contrib-
12 uting to the livestock death; and

13 “(ii) without regard to any manage-
14 ment practice, vaccination protocol, or lack
15 of vaccination by the producer relating to
16 the disease.”;

17 (2) in subsection (e)—

18 (A) in paragraph (2), in the matter pre-
19 ceding subparagraph (A), by striking “2012”
20 and inserting “2019”; and

21 (B) in paragraph (3)(D)(ii)(I)—

22 (i) by striking “at least 8 consecutive”
23 and inserting the following: “not less
24 than—

1 “(aa) 4 consecutive weeks
2 during the normal grazing period
3 for the county, as determined by
4 the Secretary, shall be eligible to
5 receive assistance under this
6 paragraph in an amount equal to
7 1 monthly payment using the
8 monthly payment rate deter-
9 mined under subparagraph (B);
10 or

11 “(bb) 8 consecutive”; and

12 (ii) in item (bb) (as so designated), by
13 striking “1 monthly payment” and insert-
14 ing “2 monthly payments”; and

15 (3) in subsection (d)(1), by striking “2012”
16 and inserting “2019”.

17 (b) EFFECTIVE DATE.—The amendments made by
18 this section take effect on October 1, 2018.

19 **SEC. 2. ELIGIBILITY OF NATIONAL GRASSLANDS FOR GRAZ-**
20 **ING LEASES AND PERMITS.**

21 Section 402(a) of the Federal Land Policy and Man-
22 agement Act of 1976 (43 U.S.C. 1752(a)) is amended by
23 striking “lands within National Forests” and inserting
24 “National Forest System (as defined in section 11(a) of

- 1 the Forest and Rangeland Renewable Resources Planning
- 2 Act of 1974 (16 U.S.C. 1609(a) land”.
